CHECK ONE:

ACTIVE - Active Members are companies/firms/individuals directly and primarily engaged in the real estate title abstract industry, or the real estate title insurance industry, and which have been continuously so engaged for the five (5) years prior to their application for membership. Attorney issuing agents, whether sole practitioners or law firms, may qualify for Active Membership. Underwriter members must have at least one agent in either Georgia, Alabama, or Mississippi to qualify for membership in the association. Benefits of an Active Membership include a listing in the membership directory, reduced registration rates for all SLTA events, a subscription to our quarterly newsletter, access to the Members Only section of our website and more.

Active - Full Membership: Annual dues are \$250, which entitles up to three employees to be Individual Members with full benefits. Additional employees may be added for \$25 each per year.

Active - Single Member Membership: Annual dues are \$150, which entitles only one individual or individual employee of business entity members to be an Individual Member with full benefits. There is no option for additional employees to be added.

ASSOCIATE - Applicants not otherwise qualified to become Active Members but whose primary business activity bears a direct relationship upon qualifying activity as engaged in by Active Members may qualify as Associate Members. Benefits of an Associate Membership include a listing in the membership directory, reduced registration rates for all SLTA events, a subscription to our quarterly newsletter, access to the Members Only section of our website and more. Associate Members do not have the right to vote, except if appointed to a committee. Then they may vote in the committee. Annual dues are \$200, which entitles up to three employees to be Individual Members with full benefits. Additional employees may be added for \$25 each per year.
